6:00 P.M. Those Present: The meeting was called to order by Selectman Paul Sadeck. Those present: Selectman Lisa A. Pacheco, Selectman Lee J. Baumgartner and Town Administrator Richard Brown. The meeting is being recorded by Selectmen Sadeck and MCCAM.

Dog Hearing - Owner John Prizio, Dog Officer, Lisa Podielsky - Mr. Prizio is 6:05 P.M. not present. Mr. Custodio states that this has been going on for almost one (1) year and he doesn't think the problem can be resolved. He knows there is another person who would come forward if they were not afraid of Mr. Prizio. He states the dogs are out every night. He believes the dogs have not gone in since February. They are always barking. After about 3 weeks he did not take them in. Lately Mr. Custodio has stopped complaining because the Police said that they cannot do anything. He knows there are others suffering in silence. Selectman Sadeck says we will have to call another public hearing because Mr. Prizio is not present. Mr. Custodio says the problem is there is no accountability. Selectman Sadeck asks Officer Podielsky to give Mr. Custodio a copy of the Law. Selectman Sadeck explains that this is a State Law and this is what we have to operate under. He also asks Officer Podielsky to please make a contact with Mr. Prizio. - Town Building Repairs Updates (Police Department Windows Selectman Sadeck says the main window has been replaced, they are working on the other windows., Town Hall Parking Lot-Selectman Baumgartner thinks this is a liability and we need to do whatever we need to do now to fix it. Selectman Sadeck agrees we need to move on this now. Mr. Brown spoke with Highway Surveyor and this would cost \$35,000.00, Selectman Pacheco says we might need to wait, I am not sure this is an unforeseen expense. Selectman Pacheco states she doesn't have an issue with fixing it however she just wants to make sure that we are following the proper protocol., Fire Department Roof-cap on chimney issue- This has been resolved per Mr. Brown and the Highway Barn Septic is out for bid.) Discuss Employee Handbook.- Mr. Brown said we discussed this and we are going to look at the bylaws first.
- Discuss Safety Committee. Mr. Brown will poll the Committee and get a date. Selectman Pacheco said she doesn't need to be there as long as the union gets the things we promised them in negotiations.
- Discuss Floater Position. Not discussed.
- Key issues Maybe we can change it to a secure passcode system instead of a key. Selectman
 Baumgartner just did this for the Coastguard. Selectman Baumgartner and Mr. Brown will work on
 this. Mr. Brown said that maybe we need to have a procedure for Town Hall regarding people meeting
 and using the facilities. Selectman Sadeck said we could have it on a level for access availability.
- Historical Commission letter from Mary Rezendes Brown. Motion (Pacheco/Sadeck) to appoint Peter Erwin an Associate member of Freetown Historical Commission.
- L.I.U.N.A. Fund per Mr. Brown we need to accept the rehab plan. Motion (Sadeck/Pacheco) to adopt the schedule of Liuna.
