# MINUTES OF MEETING OF MONDAY, JANUARY 23, 2017 COUNCIL ON AGING 227 CHACE ROAD, EAST FREETOWN, MA 02717

6:00 P.M. Call to Order Selectman Paul G. Sadeck calls the meeting to order. Also present are Selectman Lisa A. Pacheco, Selectman Robert Jose and Town Administrator Jack Healey. The meeting is being recorded by Selectman Sadeck, Ali Golz and FREECAM.

6:05 P.M. Discussion with Superintendant Richard Medeiros and Finance Director Fred Baker regarding FY18 School Budget. Superintendent Medeiros would like to get out and speak to the Board members and answer any questions they may have. He says he knows the big issue is what the schools need and what the Towns can support. We know this will be a difficult challenge. The School Committee has not taken a vote on his budget yet. We will either be reducing services or not. Mr. Medeiros says he is vested in the community. The next budget meeting is February 4 and they would love to have a rep there from the town. They aren't looking for a huge increase. Everything is level services, plus they have added a librarian. This is early and they are always waiting for the state number. Selectman Sadeck wants to know what Mr. Medeiros's contract is. He states he has essentially a 5 year contract. Mr. Medeiros says our proposed SPEDD budget is \$8 million. We would try to keep them within the district but sometimes we need to send them outside the district. This year we had 21 students come in during the school year that we had to send out of district. We are going to create some programs to defray the costs. This will be a struggle but it is something we are going to look at. The health insurance increase is 9.2% this year. We have no capital projects this year. Selectman Sadeck says those projects were debt exclusions. Mr. Baker says we should reflect that in the formula then. Selectman Sadeck says we need to not hide that within the formula. If you take out the debt, it comes to 10.1% increase. Selectman Sadeck says his concern is we did this last year and the increase is unsustainable and you refused to let the communities in on the negotiations as representatives there. At the meetings last week you said that you want to have a general override and you said it several times. Selectman Sadeck says the Town can't do this and he thinks that taxpayers need to make sure they pay attention to this. Mr. Medeiros says the question was raised and that he at no time said that, but as far as the negotiations, you vote for the number. Mr. Medeiros says if you want to sustain the level of services that we are giving now that you need to give us what we are asking for now; however if you are going to give us reductions, that is what will be reduced. Selectman Sadeck just wants to make sure the taxpayers will understand what will happen if there is an override. Mr. Baker says there is a significant

difference to last year, this year we are just trying to keep what we have, except the librarian. Selectman Jose says he was at the meeting the other night as well and depending on what the governor sends down, it may change. He wants to know have they asked about vocational services? Mr. Medeiros says we can't mirror that. We would like to bring in School Choice. We have over 80 students go to Old Colony. We can be more aggressive and he is open to things. Selectman Jose says we have space, so why can't we look at other options? Mr. Baker says they are raising fees, like cafeteria, athletic fees etc. Mr. Medeiros says but we are now taxing the communities. Selectman Pacheco says but that money goes into E&D so you can take it out of E&D. The Cafeteria is difficult, Selectman Pacheco doesn't think you should go up on that. Mr. Medeiros says the poverty numbers is 30%, which is a large number. Selectman Sadeck says but the biggest cost is salaries.

Mr. Macomber says that the Highway Department does use 1-2 contractors in addition to the crew. Selectman Pacheco asks how many subcontracts do we have. Mr. Macomber says approximately 43 and that we have more contractors but we have a few more subdivisions. We do have new contractors but have lost a lot of old ones. He notes that a few years ago, we had the exact forecast as we are having this year. Motion (Pacheco/Jose) to sign. Passed unanimously
- Discuss Regional Finance Committee Meeting from January 17, 2017. Discussion above with Superintendent and Finance Director. This discussion was moved to be part of the discussion about the FY18 budget, at 6:05pm.
- Discuss Letter from School committee. Mr. Baker explains that as long as the town agrees with the letter, they let this go; if not, then this will need to go to a town meeting to vote. Mr. Baker said this doesn't add to anything. Selectman Sadeck says this make you have less E&D in your FY18 Budget. Motion (Jose/Sadeck) to allow this to go through, motion passes 2-0 with Selectman Pacheco abstaining. She explains she doesn't need to do this, as it is not necessary.
