• Approve/Sign Contract from Greenman-Pederson, Inc for drainage improvements, as submitted by Highway Surveyor Charles Macomber. Mr. Macomber wants to hire GPI to do the drainage on Cliff Drive, Oaklawn Road and Nottingham Way

VOTE: Motion (Pacheco/Sullivan) to approve, passed unanimously.

Discuss letter from Highway Surveyor Charles Macomber regarding No Parking signs. Mr.
 Macomber has provided the Board with the measurements of the No Parking zones as requested.
 Selectman Sullivan would like to know Memorial Drive as well.

VOTE: Motion (Pacheco/Sullivan) to accept the letter and discuss, passed unanimously.

Mr. Macomber says he can get that, and that the signs are all in place, put up by the Police Department, but a hearing is needed to make them enforceable. This will be scheduled for the Board's meetings on July 16<sup>th</sup> or August 6<sup>th</sup>.

- Discuss letter from Highway Surveyor Charles Macomber regarding No littering signs. The Board previously asked Mr. Macomber to install No Parking and No Littering signs on Alexandra Drive and the access road to the state highway pit in Assonet, alongside Circle K. Mr. Macomber says the access road is state property and Alexandra Drive is private property, so the Highway Department cannot put signs in either location.
- Town Administrator's Report.
  - o Mr. DeManche will be at a procurement seminar for the next few days.
  - On the Department of Conservation and Recreation (DCR) land matter, the closing is happening this week. Mr. DeManche thanks Mr. Macomber, Sean Proventure from DCR and Legal counsel for their help on this.
