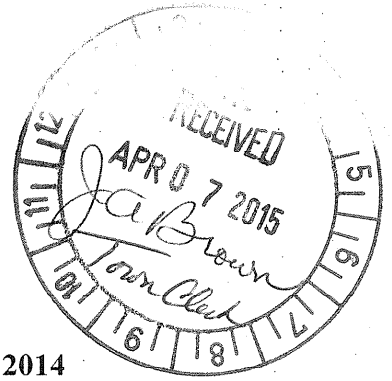

**MINUTES OF MEETING OF MONDAY OCTOBER 27, 2014**

**6:00 P.M.**     **Call to Order** by Selectman Lisa Pacheco those present are Selectman Lee Baumgartner, Selectman Paul Sadeck, and Town Administrator Jack Healey. The meeting is being recorded by MCCAM and Selectman Sadeck and John Garcia from Standard Times. Selectman Pacheco reads the Agenda aloud.

**Board of Selectmen:    Action relative to:**

- Highway Surveyor, Charles Macomber, relative to Chapter 90, Final Report – Pleasant St. - Drainage Request Motion(Baumgartner/Sadeck) to approve in the amount of \$8,500.00 and Project Request – Lang Rd. – to pave 1,214 feet by 12' wide. We will grade, compact the road. This will be done by Thanksgiving. Selectman Pacheco asks what if the state doesn't approve it. Mr. Macomber says it doesn't go anywhere. The state approves before the work is done. In that case it would be next spring. Selectman Pacheco asks about Conservation Commission. Mr. Macomber says that has been approved. Motion (Baumgartner/Sadeck) to approve this. Passed unanimously.

- Vote to open and close Warrant for Special Town Meeting November 19, 2014. Selectman Pacheco says we will hold on this. All selectman are in agreement.

- Discuss/Appoint letter submitted by Nicole Bruno to be appointed to the Historical Commission as well as letter recommending appointment by Mary Rezendes-Brown, Chairman. Selectman Sadeck reads the letter aloud. Selectman Pacheco says now they are asking to reduce it. Mr. Healey says he spoke with Mary Rezendes-Brown today and she was going to call the Personnel Chair today. Selectman Sadeck didn't hear from her today. Selectman Sadeck would like to appoint this person. Motion (Baumgartner/Pacheco) to appoint Nicole Bruno. Passed unanimously.
- Article #12 Motion (Baumgartner/Sadeck) to reconsider Art 12 and not recommend this article. Passed unanimously.
- Appoint a Citizen at Large to the Tax Increment Financing Board. Selectman Sadeck reads the letter aloud that was submitted by Mr. Paul Dunn. Motion (Baumgartner/Pacheco) to appoint. Passed unanimously.
