# MINUTES OF MEETING OF MONDAY DECEMBER 01, 2014

# COUNCIL ON AGING 227 CHACE ROAD, EAST FREETOWN, MASSACHUSETTS

**6:00 P.M.** Call to Order by Selectman Lee Baumgartner those present are Selectman Paul Sadeck and Town Administrator Jack Healey. The meeting is being recorded by MCCAM and Selectman Sadeck and John Garcia from Standard Times. Selectman Baumgartner reads the Agenda aloud.

# 6:00 P.M. Board of Health Variance – 23 Hemlock Point – Abutters Notified

Kevin Bernardo says the Abutters did not have to be notified. He reads aloud from the sheet. Mr. Healey asks why there was no abutter notification. Jamie Bassonet from Prime Engineering says the well that is affected is the residents well only no other well. Selectman Baumgartner asks Mr. Bassonnet to explain this system. Mr. Bassonet says the variances are reductions of SAS to a surface water supply from 400' to 100+, Reduction of Septic Tank to a surface water supply from 400' to 2100 and a reduction of a SAS to a private water supply well from 100' to 50+ (1 wells total) Mr. Bernardo has 2 conditions, he wants the on site well tested within 1 year of the Certificate of Compliance issuance and the residence must be a 2 bedroom deed restriction. Motion (Sadeck/Baumgartner) to adopt the variance at Mr. Bernardo's recommendations. Passed unanimously.

# Board of Health Variance - 25 Hemlock Point - Abutters Notified

3 Abutters were notified and they are present. Variances are reduction of SAS to a surface water supply from 400' to 100+, reduction of Septic Tank to a surface water supply from 400' to 100+, and reduction of a SAS to a private water supply well from 100' to 50'+.4 wells are around the areas. The adjacent wells are 78' and 84' away. The Presby Wells are a cleaner well. Selectman Baumgartner asks when you replace an old system what happens. Mr. Bassonet says the old one will be crushed and filled in. Mr. Bernardo says the conditions he would like placed on this system are the following: onsite well should be tested within 1 year and a copy of the water analysis needs to submitted to Board of Health. There will be a deed restriction. Any abutters have any issue. No issues. Victoria Morro 24 Island Road has no issues. Expansion deed is only on the Septic. No bedrooms can be added. Selectman Sadeck wants more explanation. Mr. Bassonet says that they can remodel but not add more bedrooms. Motion (Sadeck/Baumgartner) to adopt at the recommendations of Mr. Bernardo Health Agent. Passed unanimously.

#### Board of Health Variance - 6 Elm Street - Abutters Notified

No Abutters need to be notified with this address. Selectman Sadeck asks what is to assure us that this gets fixed if something goes wrong. Mr. Bernardo says this is monitored by

a service. This will have a maintenance contract. Conditions will be that we have a copy of the maintenance contract with every 6 month check. Mr. Bassonet says the protocol that DEP puts into place that they need a maintenance contract is what works. Mr. Healey wants to require a copy of the contract and copy of the reports to be on file at the Board of Health and Mr. Bernardo wants a deep hole inspection at time of construction and a restriction of maximum of 5 bedrooms. Motion (Sadeck/Baumgartner) as recommended. Passed unanimously.

# Signing of Biweekly payroll/vendor warrants Weekly Public Discussion period

Selectman Baumgartner announces the ACO flyer.

Mr. Rick Garant of South Main Street is concerned about the Road Improvement that Stop and Shop will be doing. He spoke with a representative of VHB. They said the sidewalk will be on the opposite side of the road. Mr. Healey said that the sidewalk will be on his side of the road. Mr. Garant said they can't sleep early in the morning. Mr. Healey has reviewed the plans, Geneveve Burke is who Mr. Garant spoke with. Mr. Healey said the sidewalk will be on Garant's side and this will help your line of sight. Mr. Garant said in 2003 the sidewalk was widened to help the North side and he wants to know who is saying this is safe and this is since 2012. Selectman Sadeck says we cannot stop trucks from going by your house but we can increase the road. This should have been done in 2012. Selectman Sadeck said this is now being done by Stop & Shop for the Town. Mr. Healey said the engineer will be removing some vegetation and adding a sidewalk and that will help you other than that he doesn't think there is anything else that they can insist upon. Mr. Garant says well now Stop & Shop purchased 3 housed across the road and they are 3 abandoned houses now and his property value is going down and now who knows what they are doing with the 12 acres with what they are buying up the land for. Selectman Baumgartner says we don't want anything that demeans the community. Mr. Garant feels he is being punished for being on the wrong side of the road, he would like the Town to do something on his behalf. Selectman Sadeck says that isn't our responsibility to do that on your behalf. Mr. Garant says my fight is with Stop & Shop then? Selectman Baumgartner says if you are looking for them to buy your property then you would need to speak with them and it doesn't feel right for us to speak to them on your behalf. Mr. Healey says he will see if he can get a phone number for him.

Attorney Reich said he spent some time speaking with Adam Andrews at Amazon and Ken Fiola at FRDA the difference was binding as long as it was certified and the big issue was the non-disclosure agreement. Attorney Reich said he gives the blessing.

- Town Administrator's Report Senior Work Off Program to approve one applicants due to extra ordinary expenses. Selectman Sadeck says he was first told the income will not happen in the future. Motion (Sadeck/Baumgartner) to approve. Passed unanimously.
