MINUTES OF MEETING OF MONDAY FEBRUARY 22, 2016

COUNCIL ON AGING 227 CHACE ROAD, EAST FREETOWN, MASSACHUSETTS

5:30 P.M. Call to Order Lee J. Baumgartner calls the meeting to order. Others present are Selectmen Paul G. Sadeck and Selectmen Lisa A. Pacheco.

5:30 P.M. Board of Health discussion with South Coast Neighbors United - Roger Cabral, Treasurer of SCNU, does a presentation for the South Coast Neighbors United -

Selectman Baumgartner explains that the Governor of New York vetoed a liquefied natural gas (LNG) project in his state recently, which shows that SCNU needs to voice their concerns with the Governor, not the Board of Selectman, because we cannot do anything here. The project is mutually dependant: Freetown is mutually needed for Acushnet. Mr. Cabral voiced a number of concerns about the proposed project, as follows. The property is zoned residential and we are arguing this point. They are clearing a 250 acre site, 40% of that wetlands. What they have on site is an LNG storage tank, shown on the monitor. This is located in a heavily residential area. Eventually, they will have tanks 6 times larger than the tank that you see in Boston now, with the tanks in Everett even larger. If you look at Gillette Stadium it will be 17 yards high. Each of 2 tanks it will be 90 yards across. 25% of New England's storage capacity will be in Acushnet and the rest will be across 35 other facilities. Freetown should care about this because the Acushnet portion of the project doesn't exist without Freetown. The gas lines will be 24" around. Buried 3' down. The lines will be run wherever they want to. They take a 50' easement and you lose that above property and you don't get to use the above property. Please Google the dangers of the pipe lines. There are risks. 94-2013 700 serious incidents of serious incidents with 1100 property damages. Once you have the pipe line running through your property you have the risk. It is more than 1 incident per week. In the US it is cheaper to us Gas but State Senator Stan Rosenberg has different plans to use different things like Solar. They are doing this because they want to export it internationally. We will pay the prices and this has nothing to do with the energy price for New England. This will be the largest LNG storage place and this will be a terrorist target. The only people that will respond will be 911. You have the ability to not have them survey public land. Residents that can refuse the survey, please do that. In all, Mr. Cabral urges the Freetown Board of Selectmen to tell them we don't want this in our Town. Selectman Pacheco states we have already said they could not survey the public land. Wendy Graca said that SCNU wants to know that we have the Town's backing and that is what we are asking. Selectman Baumgartner says that this was a great presentation.

Motion (Sadeck/Pacheco) 5 minutes break. Passed unanimously.

Weekly Public Discussion:

• Meghan Corrigan, 9 Beach Street, speaking about South Main Street. Ms. Corrigan says she has gone to the Town Hall and complained about trash along S. Main Street and no one knows if it is MA Highway or Town's job to clean this up. This is a yearly occurrence. Ms. Corrigan also has concerns about Stop & Shop trucks using Exit 8 of Route 24. Selectmen Pacheco and Sadeck say the Town can't force them use that Exit 8B, we can only guide them. We might need to send a reminder to them to use 8B. Ms. Corrigan also says you don't see growth here in the Town. Selectman Pacheco says you may not see the small town growth, but we do have growth here. Selectmen Pacheco says small businesses have a big problem with the sewer line here in Town.
