
# Freetown Board of Selectmen Meeting Minutes Monday, February 6, 2023 – 6:00pm Police Station Community Room 15 Memorial Drive, East Freetown, MA



#### Call to Order

Selectmen Matthews called the meeting to order at 6:00pm. He noted the meeting is being recorded and will be on the Town's YouTube channel. He also noted the Board would be going into Executive Session for the reasons stated below and will return to open session. Selectmen Jared Zager, Selectmen Carlos Lopes, Interim Town Administrator Deb Pettey, Administrative Assistant Lola Furtado, and Executive Assistant Lu-Ann Souza were also present.

  - Selectmen Matthews stated about in the past having open litigation against Excel and not wanting to accept donations from Excel but we do not have open litigation anymore. Part of the settlement was to have Excel mitigate their impact they are having on the town as much as possible. Would not gifts be part of that kind of agreement or mitigation. Selectmen Lopes suggested they give a non-monetary. Giving the neighborhood days back for quiet weekends. Selectmen Zager stated as a tax paying business in town willing to make a donation he is ok with accepting the donation. It does not reflect the settlement made in the past. Stephen Tripp would like to see them pay for clean up of trailers and grounds on the street. Until sound testing passes or the hazardous fibers are cleared up, then they will be a good resident/neighbor. Leia Adey stated if you get an independent environmental consultant to come out and do all the work that should be done at that location and they get a clean bill of health and everything looks great and the residents have nothing to worry about, then you say, ok, now you can start doing good for the town. They are trying to buy their way into town. Selectmen Matthews stated there has been a lot of bad blood but, they are trying to present a better image. It is foolish for the town to not take the money and do good with it for the town.

Town Clerk Cheryl Estrella stated the Town Seal is governed by Massachusetts General Law and says Town Clerk is the keeper of seal and it should only be used for documents and authorized information from the Town Government. They have come back and said it is more of a copyright and that the copyright expired in 1929. Town Council said she should send out a cease-and-desist letter, but that the Board of Selectmen have authorization over the seal. She gave information about the prohibited uses of the Town Seal. It is property of the Town and the Town is not in the business of being a business and creating profit. It is not something that we could be selling merchandise and

devaluating or de-authenticating the importance of the Town Seal. The Town Seal should be on Government documents and Government property. The Town may consider not creating an official Town Seal but perhaps something that represents the Town of Freetown that with written permission can be authorized to be used with no profits. Freetown sites on some type of an emblem that way that could be used where it is not duplicating the official seal. Because then you are setting a precedent if you allow one person to do it and for everyone else. Selectmen Matthews likes having the idea of Freetown branded stuff but the fact that it is the actual seal is the sticking point. Selectmen Lopes mentioned the difference of a copy of the seal versus the embossed raised seal. Ms. Estrella stated it is all the same thing. As with vital records the application of the embossed seal is what signifies a document as official and it is content authentic. A facsimile copy of a vital record is insufficient for most purposes in the absence of embossment. When you have the brands on clothing it is a form of identification that you work for the Town of Freetown. You have the authority to represent the Town of Freetown. It is two different things. Other Towns have created a logo to advertise such as Mattapoisett and Lakeville. Fall River had a contest last year. But not looking so similar to the Town Seal. Selectmen Zager suggested having the children in town submit something like the Parade and Fireworks t-shirts do every year but have ours design for 10 years. He likes the idea of doing something that people can use that's not official. Selectmen Lopes would like to see a different version of the seal. Ms. Estrella would like to see a big enough difference on the new version. Selectmen Matthews asked Ms. Estrella if we were sending a cease-and-desist letter, which Town Council recommended but to also get authorization from the Board of Selectmen. The Selectmen would like to see an alternative graphic design depicting the Town.

Ms. Pettey stated this requires two-thirds of the towns within Bristol County to approve this retroactive COLA. Chief Abbott stated it is not on the full pension, it is only on the first \$18,000.00.
