
Freetown Board of Selectmen

Meeting was held in person and virtually



Call to Order

Selectmen Trevor Mathews at 6:30pm called to order the Freetown Board of Selectmen Meeting. In attendance were Selectmen Jared Zager, Interim Town Administrator Deb Pettey, Executive Assistant Lu-Ann Souza, Board of Health Agent Keven Desmarais, Board of Health Member Margaret French, Steven Tripp and via Zoom is Selectmen Carlos Lopes.

The meeting will available for in person attendance and on Zoom – On July 16, 2022, Governor Baker signed into law An Act Relative to Extending Certain State of Emergency Accommodation, which, among other things, extends the expiration of the provisions pertaining to Open Meeting Law to March 31, 2023. Specifically, this extension allows public bodies to continue holding meetings remotely without a quorum of the public body physically present at a meeting location, and to provide "adequate, alternative" access to remote meetings. This meeting of the Freetown Board of Selectmen will be conducted in person as well via remote participation to the greatest extent possible. With Selectmen Matthews on the Regional Finance Committee Ms. Pettey updated the rest of Board of the school budget of Forty-Five Million, Five Hundred Sixty-Nine Thousand, Five Hundred and Thirty Dollars. An increase over last year's budget of Two Million, Two Hundred and Twenty-Eight Thousand, Eight Hundred and Twenty-Nine Dollars for a 5.14% increase in the overall Regional District budget. The towns can only levy an additional 2.5% yearly and this raised alarms. Ms. Pettey began inquiring with the School Committee and the Regional Finance Committee that this is not a sustainable budget. The assessment to the town was Thirteen Million, Twelve Thousand, Seven Hundred and Fifteen-Dollars last year. There is also state aid and Lakeville's portion that makes up the difference. They were originally proposing an 8% increase. Ms. Pettey let the School Committee know the town could not do that after last years increase. The assessment right now is 1.1% increase over last years for a total of Thirteen Million, One Hundred and Fifty-Five Thousand, Eight Hundred and Forty-One Dollars to the Town of Freetown. The way they came down on the towns assessment is by using some of the E and D Funds, also the Governor's state aid has increased. The overall budget had decreased from Forty-Five Million, Five Hundred and Sixty-Nine Thousand, Five Hundred and Thirty Dollars to Forty-Five Million, Two Hundred and One Thousand, Five Hundred and One Dollars. A decrease of roughly Three Hundred and Sixty-Nine

Thousand Dollars over their original ask. Her concerns are they are using E and D funds to reduce the assessment which is not sustainable. She is still concerned with the overall top number and long-term budget increase. The Governor has increased state aid but if the stated should have financial issues in the future they will reduce the state aid and then the town will be liable for those funds. They have worked diligently to get the assessment down for the town. We are still at the bargaining table trying to see if they can cut some other expenses out to get us a more sustainable long-term budget. We do have a good school system in place. Selectmen Matthews stated Lakeville also has the same concerns. We did vote on this and this is the maximum budget. This budget has nothing to do with Bristol Plymouth. This assessment is only for the Freetown–Lakeville Regional School District.
