A discussion of residential and commercial factors determining the tax rate. Last year's shift was a 1.595. If it stays the same the average residential bill will increase by \$236. The average commercial bill would increase by \$44.00. Changes coming up for fiscal year 2024 is that this year is Stop and Shops last year of their tiff. Right now, Stop and Shop is assessed at 99% of their value, next year will be their first year at 100%. Fiscal year 25 will be the first year that Stop and Shop pays a personal property tax because the old form of tiff completely exempted personal property from the duration of the tiff. This is not a thing anymore. Amazon does not get that benefit. Amazon's tiff will reduce from 75% to 50% so they will be paying quite a bit more. It will also be the year we start paying toward the Bristol Plymouth High School which we be for 30 years. Historically the shift has always favored residential to some degree. Next year you are probably going to take a good hard look at that to try to reduce the Bristol Plymouth burden from the residents, especially in a year when the businesses are going to pay more. We run 18 months behind the market. This year fiscal 24 we used sales from calendar year 2022. We are always behind the fiscal year. There is a common misconception from for the average person that the value of the property whether it goes up or down such as my property values are going up so my

taxes are going to go up and that is not how it works. The property values go up and down and the tax rate goes up and down, the opposite to make up for it because the constant is what we need to collect for a levy. So given a particular levy, the amount that individuals will pay would be the same regardless of what their value is because overall we are going to make that adjustment in the tax rate.
