Call to Order

Governor Healey signed into law Chapter 2 of the Acts of 2023 which, among other things, extends the expiration of the provisions pertaining to Open Meeting Law to March 31, 2025.

Specifically, this extension allows public bodies to continue holding meetings remotely without a quorum of the public body physically present at a meeting location, and to provide "adequate, alternative" access to remote meetings. This meeting of the Freetown Board of Selectmen will be conducted in person as well via remote participation to the greatest extent possible. The police station is a municipal water supply could we pump over to the COA and bypass the old police station. Another option would be to split the well. Also need to consider, where to put the new filtration system at the COA.

We are waiting to hear back on the grant next week. There are two proposals. One is, one handicap toilet in each men/woman's bathroom the other is two stalls in each but that pushes into the Assessor's Office. We also need a galley kitchen or pantry type so that we

don't have to wash dishes in the bathroom sink. I will get the department heads together and discuss this further with them.
