Located at 2 Memorial Drive. Access from Council on Aging and Central Park parking lot. Includes excavating, adding accessible trail materials, reduce slopes, install culvert, wayfinding signage, benches and picnic tables. Improving the trail would expand usage to seniors and youth population due to the proximity to the Council on Aging and Freetown Elementary School. Estimated project cost of \$100,000.00. \$75,000.00 from a grant and \$25,000.00 match from highway staff time. We would have 2 years for the construction grant.

Porta johns will need to be ordered and the logistics of removing the asbestos. Selectmen Lopes would like to see a 4th option with a break room for employees. Option C is the best option for the handicap accessible issues and not having to move or lose office walls.
