Freetown Board of Selectmen Meeting Minutes Monday, March 4, 2024, 6:00pm Police Station Community Room 15 Memorial Drive, East Freetown, MA

### **Call to Order**

Selectmen Trevor Matthews called the meeting to order at 6:00pm. Selectmen Jared Zager, Selectmen Carlos Lopes, Town Administrator Deb Pettey and Executive Assistant Lu-Ann Souza were also present. Selectmen Matthews mentioned we will be going into Executive Session for the reason listed below and return to open session. He also noted that the meeting will be recorded and available on the Town's YouTube Channel.

- Vote: was approved in a unanimous roll call vote

- 3. Presentation from Police Chief Rose on results of the Citizen Survey for Programs and Services

Chief Scott Rose presented the results from the Citizen Survey for Programs and Services to the Board. They received over 400 responses from the community. 90% of the survey were Town of Freetown residents. 30% worked in Freetown. 95% regularly travel through Town. Participation was an equal split between Assonet and East Freetown. The largest age group was over the age of 60. Services: 61% of responses supported a School Resource Officer and 60% of responses supported a FPD Boat Enforcement Unit at the Boat Ramp and Town Beach. 49% of responses supported a FPD Motorcycle Unit. 70% of responses supported a FPD Drone Unit. Responses for The R.A.D. Self Defense Program was around 70%. The FPD Citizens Academy 60%. The Junior Academy was also well received at 70%. The most important services out of all of them were the School Resource Officer and the Drone Unit. Second set of the most important programs listed was the RAD Program and the Junior Police Academy. Board thanked Chief Rose for this presentation and noted that this information is very valuable and will help the Town a great deal.

Ms. Pettey let the Board know that the old shed was removed from the boat ramp and is now at the Transfer Station and was not of use to the town.
