# Freetown Board of Selectmen Meeting Minutes

Thursday, September 16, 2021 – 5:00pm

Meeting will be held virtually

#### Call to Order

Selectmen Matthews called the meeting to order at 5pm of the Board of Selectmen meeting. He noted we are having a virtual meeting and have Executive Assistant Lu-Ann Souza read Governor's Baker Order first.

Pursuant to Governor Baker's March 12, 2020, Order Suspending Certain Provisions of the Open Meeting Law, G.L. c. 30A, sec. 18, and the Governors March 15, 2020, Order imposing strict limitation on the number of people that may gather in one place, this meeting of the Freetown Board of Selectmen will be conducted via remote participation to the greatest extent possible. Specific information and the general guidelines for remote participation by members of the public can be found on the Town of Freetown's website, www.freetownma.gov. For this meeting, members of the public who wish to view this meeting will be able to view the meeting via livestream at youtube.com/Freetownma.gov/FREECAM. No in-person attendance of members of the public will be permitted, but every effort will be made to ensure that the public can adequately access the proceedings in real time, via technological means. In the event that we are unable to do so, despite best efforts, we will post on the Town's YouTube Channel an audio or video recording, transcript, or other comprehensive record of proceedings as soon as possible after the meeting.

# Board of Health

19. Public Health Nurse update.

Public Health Nurse Lori Desmarais stated cases for Freetown since the beginning is 1083, currently 29 actives cases, 36 cases during the last 2 weeks. Freetown positivity rate is up at 5.14%. Fall River is at 4.64% and New Bedford is at 4.84%. Lakeville is at 5.87%. July, we had 18 cases, no hospitalizations, and no deaths. In August we were up to 73 cases, 1 hospitalization and no deaths. For September we are at 35 cases for the month. 40 % of the cases are vaccinated the others are not. As far as the sequencing of the specimens, they don't sequence all of them but of the ones they have, for July 10 of those 18 cases were a delta variant, and for the month of August 25 of the 73 are also the delta variant. September numbers are not in yet for sequencing. Mosquito update and testing have not been any triple E cases in mosquitos, animals, or humans. There has been for West Nile Virus 117 mosquito that have tested positive, 1 animal case in Middlesex County and 7 humans. 1 woman of West Nile Virus in Bristol County. Please stay vigilant as far as using mosquito repellent and observing those not being outside during the peak hours dusk to dawn. Towns around us Fall River has gone up to moderate risk. Freetown is still at low risk for both, according to the state. we actually haven't had any positive cases of mosquitos in town, but Fall River has and is right next door to us.

Public Health Nurse Lori Desmarais emailed over DPH Guidance for Persons in Quarantine due to Covid-19. Ms. Pettey asked if we are allowed to mandate this protocol to union employees. Mrs. Desmarais said these are the guidance per Mass DPH and wouldn't be any different whether they were a union or not.
