Sonia Connelly, the applicant's representative, stated that they would like to cut a small path to the pond to bring kayaks down. Mr. Desmarais stated that he would like to do a site inspection prior to the next meeting.

Continued Notice of Intent - 11 GM Way

Mr. Desmarais called the hearing back to order. Byron Homes, of Holmes Engineering, stated that they have submitted the alternative analysis and received a DEP file number with no comments from DEP. Natural Heritage also did not have any comments.

They are proposing to raise the existing dwelling above the flood elevation, convert the tight tank to a septic tank, and install water line and force main. Craig Cabral, the applicant, stated that they will put siltation control around the house.
