## Opening Statement, read by Chairman Gary Martin.

Pursuant to Governor Baker's March 12, 2020 Order Suspending Certain Provisions on the Open Meeting Law, G.L. 30A, section 19, and the Governor's March 15th, 2020 Order imposing strict limitations on the number of people that may gather in one place, this meeting of the Freetown Finance Committee is being conducted via remote participation. ## **TOPIC: Transfer Requests**

Mr. Martin states the first transfer order is from the Finance Committee, dated on March 3, 2020. The Transfer order is for \$800 to cover the salary of the Finance Committee Clerk. The Board of Selectman approved the amount.

#### Transfer Request

Mr. Martin states the second transfer request is for \$250 from the Highway Department, dated February 26, 2020. The amount is to cover the overtime for Highway Department employees. The Board of Selectman approved the amount on March 9, 2020.

#### Transfer Request

Mr. Martin states the third transfer request is from Town Administrator, David DeManche, dated March 12, 2020, for \$16,408.46 to be transferred from the reserve fund to cover Legal Fees. Presently, there is a balance of \$57,311.59 in the account, and if the transfer is approved, \$73,720.05 will be the new balance.

The reason for the transfer request is the amount of legal fees are higher than expected in Fiscal year 2020. Various legal matters are still outstanding, we have 3 Town Meetings yet to be billed, and the remaining bills will represent a monthly average or slightly higher amounts. The amount requested represents the average legal bill in FY 20, multiplied by 5 for the number of bills yet to be received, and an additional \$5,000 has been added in order to avoid a transfer request in the future.

Mr. Martin states according to the email correspondence from Ali Golz, she believes the bills will not be as high as Mr. DeManche anticipates, due to courts being inactive, and lawsuits being on hold, therefore the current balance should be sufficient. If that is the case, Mr. Martin states if the balance is not enough, another transfer request can be submitted in the future

Mr. Alderson states the Finance Committee does not pay estimated bills, and the committee has a grace period after June 30th, if there are any residual bills.

## TOPIC: New business/open Discussion

Mr. Alderson states the committee should look into level funding the budget for the Town, for every department and employee, as opposed to approving budget increases to be rejected later due to shortfalls in the state budget. Mr. Alderson also expressed concern the Finance committee is not represented at union contract negotiations and due the current crisis having an unknown impact on state budgets, Mr. Alderson suggests contacting the Superintendents Office for any financial information the committee can use.

Mr. Martin questioned Ms. Shea-Dupras if the Finance Committee is involved in any Union Contract negotiations. Ms. Shea-Dupras answers the Town of Wrentham is not involved, nor is Foxboro.

Mr. Wilkins questions Ms. Calheta if she has any information regarding the School Budget coming up short due to the state budget. Ms. Calheta stated the last meeting was canceled, but she is sure no decisions have been made and is waiting for more information.
