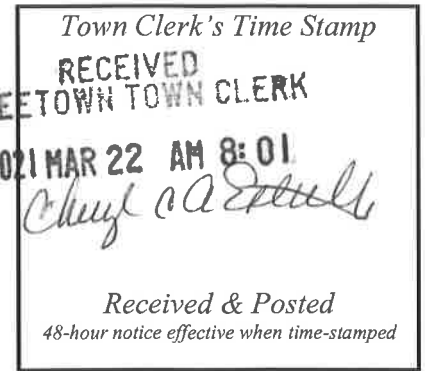

Ch. 30A, §18, and the Governor's March 15, 2020 Order imposing strict limitations on the number of people who may gather in one place, this meeting of the Freetown Town Meeting Study Committee will be conducted via remote participation to the greatest extent possible.
