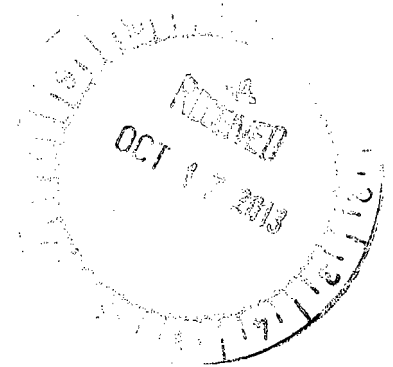

Minutes of the Meeting October 22, 2012

Update on Application # 0506 – Whitney Academy

William Logan, contractor for the project.

Tipping fee to be paid on application- \$16,687.50. Tipping received to date - \$16,000.

Remark on the permit stated that the work should be completed by September 30, 2012.

Mr. Logan has requested an extension until October 31, 2013.

Permit expires March 26, 2013

Site inspection conducted October 13th, 2012.

Mr. Logan addressed the board. He will have the area loamed and seeded by the end of the week. The board agreed that he would need to stabilize the area possibly with a jute mat. The drainage still needs to be installed as well. The yardage to be removed increased to 70,150 yds and payment in tipping fees has increased.

Update on Application # 0507 – Cape Cod Aggregate

DEP have been conducting tests on area wells and will be conducting another round of testing. The Board is waiting for all the information to be presented before any discussion of conditions and vote taken.

Application fee: \$85.00 paid
Tipping fee: none at this time Request to carry over 1,162 yards to be removed 2012 – 2013.
Bond expires April 5, 2013
Conditions signed with request for waiver #26 & # 27.

Motion made, K. Desmarais to renew the permit as stated. Seconded by M. Ternullo. All in favor.

Permit # 0519- 5 acres of an eleven acre site behind 53 Dr. Braley Road on the north side and west of Dr. Braley Road halfway between Ann Records Lane.
Owner Richard Spencer & Operator K. R. Rezendes .

Application fee: \$85.00 paid
Tipping fee: none at this time requesting to carry over 659 yards to be applied to 2012-2013
Bond expires December 5, 2013
Conditions signed with the request to waive #26 & #27.

Board asked the clerk to follow up with the renewal of the bond in December. Motion made, K. Desmarais, to renew the permit as presented. Seconded by M. Ternullo. All in favor.

Permit #0520- 5 acres of land located at Braley Road
John Mello owner & operator.

Application fee: \$85.00 paid
Tipping fee: none at this time no material being removed.
Bond expires October 20, 2013
Conditions signed with the request to waive #26 & #27

Motion made, K. Desmarais, to renew the permit as presented. Seconded by, M. Ternullo. All in favor.

Permit # 0521- 4 acres located south of Chace Road adjacent to the cranberry bogs
Owner, Timothy Ashburn & Operator John Mello, J M Equipment

Application fee: \$50.00 paid
Tipping fee: \$500.00 for 2,000 yards paid
Bond expires October 20, 2013
Conditions signed with the request to waive #26 & #27

Motion made, M. Ternullo, to renew the permit as presented. Seconded by, K Desmarais. All in favor.

Request to amend spring permit # 0516 to reflect an additional 16 acres was received from Mr. K. Rezendes. The area was operated by Baasch Equipment and owned by Mr. Peter Lanzeria .

The operator has gone out of business and the owner's estate sold the area to Mr. Kenneth Rezendes.

Application fee: \$ 290.00 paid

Tipping fee for 20,00 yards to be removed - \$5,000 paid

Bond presently is for 4 acres for the amount of \$16,000 (\$4,000 per acre)

Conditions signed with the request to waive #26 & #27

Motion made, K. Desmarais to include the new area upon the condition: Mr. Rezendes sent a request in writing and the bond is increased to reflect the new area. Seconded by M. Ternullo. All in favor.

Motion made, K Desmarais to approve the Bills Payable. Seconded by M. Ternullo. All in favor.

Motion made by K. Desmarais to approve the payroll. Seconded by, M. Ternullo. All in favor.

Motion made, K. Desmarais to adjourn at 6:46 p.m. Seconded by M. Ternullo. All in favor.
