

MINUTES OF MEETING OF MONDAY NOVEMBER 04, 2013

FREETOWN ELEMENTARY SCHOOL-ACTIVITIES ROOM 43 BULLOCK ROAD, EAST FREETOWN, MASSACHUSETTS

6:00 P.M. Call to Order Meeting called to order by Selectman Paul Sadeck. Those present: Selectman Lisa A. Pacheco, Selectman Lee J. Baumgartner, Town Administrator Richard Brown and Town Counsel Jeff Blake. The meeting is being recorded by Selectmen Sadeck and MCCAM.

Signing of biweekly payroll/vendor warrants Weekly Public Discussion period

Mr. Rich Daley from Nestles Lane, East Freetown speaks to the Board regarding Nstar issues. He would like guidance from the Selectmen regarding taking over the power lines. He wants to know where this stands. He said he has spoke with Nstar and they say this was never done. There are 7 Families who are impacted by this and Nstar said they will not fix this problem. A. State Rep. had to intervene last year to get their electricity turned back on. The residents were without power for 19 days last year during the winter. Nstar says the residents own the lines. The residents need an arbitrator to help them. Mr. Brown says he understands the issue is not the lines it is the poles. Nstar was supposed to provide a summary of this. Mr. Daley states he has the summary. Mr. Brown has not seen this yet and he would like a copy if Mr. Daley can give it to him. He says that there is not a lot the Town can do. Selectman Pacheco asks about the list Mr. Daley is speaking about. Mr. Daley states Nstar will not do work on lines that are not their own. Selectman Pacheco would like to check the Planning board minutes and also knows of a community member who works for Nstar who may be able to help us with this matter. She cautions that this will take time. Mr. Daley says it was in 1997 or 1998 that the Selectman said they would help the residents and the Town would take over the lines. Selectman Sadeck asks who repaired them after the storm. Mr. Daley says the residents contacted a private contractor to do the work. Selectman Sadeck asks if they have had issues in the past. Mr. Daley said no not really just this past year. They had to call the Fire Department and it wasn't until the Fire Department called Nstar that they responded. This is the only reason in his opinion why they came out.

Rev. Dias would like to invite senior residents to his Annual Luncheon on November 22, 2013 at Noon.

Selectman Sadeck would like to acknowledge the Police Department's excellent job with the recent marijuana bust this past Saturday. He would also like to congratulate Officer Anthony Pereira and Officer Raposo on their new jobs at the State Police.
