Water Rate Study

• Chandler has been in contact with Representatives from Environmental Partners, he sent them the remaining information needed, and he's waiting to hear back.

Meter Replacement

- O Hydrant meter is used for high volume flushing (in spring before bleeders are turned on and fall after bleeders are turned off) and would be an asset to the department as a tool to track how much water is accurately be flushed, and, will allow us to get credit from City of Fall River for the water allotted for flushing/bleeding.
- o Keven has gotten quotes for a new hydrant meter and they are \$1,500-\$2,500 per meter and suggests researching multiple companies who sell these meters in order to save money and still get a great quality meter.
