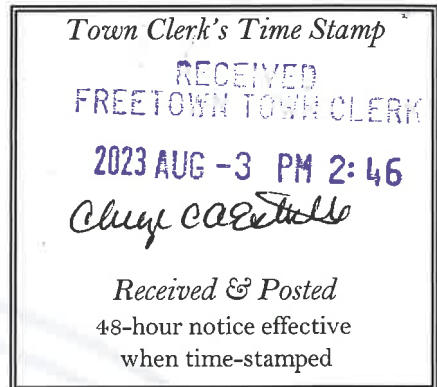

The meeting will be available for in person attendance and on Zoom – On March 29, 2023 Governor Healey signed into law Chapter 2 of the Acts of 2023 which, among other things, extends the expiration of the provisions pertaining to Open Meeting Law to March 31, 2025. Specifically, this extension allows public bodies to continue holding meetings remotely without a quorum of the public body physically present at a meeting location, and to provide “adequate, alternative” access to remote meetings. This meeting of the Freetown Board of Selectmen will be conducted in person as well via remote participation to the greatest extent possible. As part of the Safe Routes to School program the Town of Freetown would need to establish a reduced school speed limit zone that will begin 500 feet northwest of Memorial Drive on Bullock Road and extend along Bullock Road 500 feet southwest past the Freetown Elementary School entrance.
