# Freetown Board of Selectmen Meeting Minutes Monday, March 25, 2024, 6:00pm Police Station Community Room 15 Memorial Drive, East Freetown, MA

#### Call to Order

Selectmen Trevor Matthews called the meeting to order at 6:00pm. Selectmen Jared Zager, Selectmen Carlos Lopes, Town Administrator Deb Pettey and Executive Assistant Lu-Ann Souza were also in attendance. Selectmen Matthews noted the meeting was being recorded and would be available on the Town's YouTube channel. He noted the Board would be going into executive session for the reason listed below and would be returning to open session.

- 4. Presentation on the Proposed Planned Development District (3A MBTA Communities requirements) from SRPEDD and Planning & Land Use Administrator

Victoria Alfaro Duran, Robert Cabral and Taylor Perez from SRPEDD discussed the requirements of the Commonwealth of what Freetown Planned Mixed Use District (PMUD) needs to do to become a Planned Development District (PDD). Working with the Planning Board and Zoning Board, the requirements are multi-family housing, 16 units per acre, 50 acres in size for a total of 750 units for Freetown. They suggest modifying the plan mixed use district. Reasons are it is close to the Freetown Station site which is a requirement for towns with a station. This bylaw is aiming to achieve a market rate for multi families with no specifications of family size or senior housing. The affordability is set by the Department of Housing and Urban Development (HUD) at the federal level. The MBTA will not require the town to put forth new infrastructure, such as a sewer extension. It will be a private market tool where the developer will do the math and decide. SRPEDD has services that can help with this. There are new programs coming out in responsive to MBTA communities which is the Housing Works Infrastructure Program and is through the Community One Stop for Growth Program. SRPEDD is aiming to pass the bylaw at the Spring Town Meeting, and if we need to amend this, we still have the Fall Town Meeting. If there is not a zoning bylaw adopted, we will be out of compliance with the law on Dec 31, 2024.

5. Presentation on potential program survey to residents from Community Program Director

Community Program Director, Kylie Botelho, reviewed her proposed survey to put out to the public to ascertain what type of program the residents of Freetown are interested in having provided.

Freetown Police Chief Scott Rose stated the parade route starting at KRR Fields interrupts the flow of traffic on the ramps of South Main Street and Route 24. Having to stop traffic has been problematic. The traffic builds up to the main highway area. It has been suggested that we shorten the parade route to assist and avoid the ramp closures and redirect the traffic flow in a separate direction. The potential staging area of Ridge Hill Road and Campanelli Drive, even the property belonging to the MBTA would benefit the town and the Parade and Fireworks Committee to safely stage and deploy the floats and parade walkers such as our children, parents and seniors and veterans, in a safe manner and a shorter distance. This will also impact the Police Department and its personnel assignments, not needing four or five officers on that side of town and can use them north of Ridge Hill Road and along the parade route.

Advertising signs are out and around town, on the website, Facebook, Mass Hire and thehandshake.com for local colleges students. Season starts Memorial Day weekend. A suggestion was to hire two managers and alternate weekends. Management starts at \$22.00 an hour, attendants at \$18.00 an hour. A suggestion was to reach out to the Long Pond Association members.
