**Call to order:** Mike Motta called the meeting to order at 1:18 p.m. The clerk then read a statement describing orders by the Governor suspending the Open Meeting Law and permitting the holding of meetings via remote participation during the coronavirus pandemic. Also, in conformance with these orders, all votes taken during this meeting were by roll call.

**Approval of Minutes**

- A motion was made by Mr. Field, seconded by Mr. Motta, to approve the minutes of the December 28, 2020 meeting. The motion carried unanimously.

**Executive Session**

A motion was made by Mr. Field, seconded by Mr. Motta, to enter into executive session to comply with the provisions of any general or special law; specifically, to discuss Real Estate and Personal Property abatement applications which are not open to public inspection (per M.G.L. Chapter 59, Section 60) and to return to open session afterward. The Assistant Assessor noted there were no Personal Property abatements, and asked Mr. Motta if there was any new information regarding the Appellate Tax Board cases since those were also listed as potential topics. Mr. Motta said there was no new information on those items. When polled, the members voted as follows: Field – Aye, Motta – Aye.
