Date of Birth:

Check dates of birth for any errors and make changes as necessary.

Occupation:

This is your job title or profession, not where you work. Mark any changes necessary.

Veteran:

Place a “Y” in this column if you are a U.S. Veteran. In accordance with M.G.L. Ch. 51, Sec. 4d, information collected in this column is not a public record and shall only be disclosed to qualified individuals.

Nationality:

If you are not a citizen of the United States, please enter the country from which you have citizenship.

Moved/Deceased:

Put a line through the person’s name and enter an “X” if the person **moved** or the **date deceased** if applicable. If the person moved, please enter their new address in the space at the bottom of the form.

# of Dogs:

List the number of dogs in your household. For your convenience, a dog license application/renewal form is included with this census mailing for any dogs you may have.

Remember to sign & date the form – any changes cannot be made without a signature.
