To either of the Constables of the Town of Freetown,

GREETINGS:

In the name of the Commonwealth, you are hereby required to notify and warn the inhabitants of said town who are qualified to vote in elections to meet in their respective Precincts, viz:

The inhabitants of **PRECINCT 1**, **PRECINCT 2** and **PRECINCT 3** at the **FREETOWN ELEMENTARY SCHOOL GYMNASIUM**, Memorial Drive entrance on **Monday, April 4, 2022** from **12 Noon – 8:00 p.m.** for the following purpose.

To cast their votes in the Annual Town Election to choose all necessary officers for the ensuing year on one ballot, viz:

- ONE (1) SELECTMAN, BOARD OF HEALTH and PERSONNEL BOARD MEMBER..... for three years**
- ONE (1) ASSESSOR..... for three years**
- ONE (1) CEMETERY COMMISSION..... for three years**
- THREE (3) FINANCE COMMITTEE..... for three years**
- ONE (1) HOUSING AUTHORITY..... for five years**
- TWO (2) LIBRARY TRUSTEES..... for three years**
- ONE (1) PLANNING BOARD..... for five years**
- ONE (1) WATER & SEWER COMMISSIONER..... for three years**
- ONE (1) WATER & SEWER COMMISSIONER..... for one year unexpired**

You may vote for every position on the ballot for the **FREETOWN LAKEVILLE REGIONAL SCHOOL DISTRICT COMMITTEE** regardless of where you reside in the District.

- ONE (1) REGIONAL SCHOOL DISTRICT COMMITTEE – Freetown..... for three years**
- ONE (1) REGIONAL SCHOOL DISTRICT COMMITTEE – Lakeville..... for three years**
