Warrant Article 5

- This article is written as follows: To see if the town will vote to transfer the Six Hundred and Fifty Thousand Dollars (\$650,000.00) of unused funds appropriated at the June 5, 2017 Annual Town Meeting under Article 6 for the South Main Street Water and Treatment and Filtration System to the Capital Stabilization Account; and/or take any action relative thereto.
- Paul Sadeck states that due to a very high THM reading from Fall River which needed to be reported to MassDEP, it is not prudent to move this money back to Capital Stabilization at this time just in case MassDEP will require the Town of Freetown to take corrective action in response to the THM issue.
- Also, an expense directly related to this filter site is coming and that is the cost associated with doing a 21-E Environmental Study executed for the land being donated by Ashland for the possible future filter site.
- A letter shall be written to the Board of Selectmen and signed by the Commissioners
- Paul Sadeck makes motion to vote to withdraw article from Special Town Meeting. Brad Paiva 2nd. All in favor. Motion carried.
