The Freetown Zoning Board of Appeals will conduct a public hearing on **Wednesday, December 9, 2020**, at **6:00 p.m.** to act on the petition of **Russell Pelletier**. The petitioner is requesting a **special permit** to create an **accessory apartment** at **119 Bullock Road, East Freetown, Mass.** (Assessors' Map 248, Lot 82). The Town of Freetown Protective By-Laws (Article 11, Section 11.19) require a special permit for the creation of an accessory apartment.

3. **Public Hearing – 28 Huron Ave**

The Freetown Zoning Board of Appeals will conduct a public hearing on **Wednesday, December 9, 2020, at 6:00 p.m.** to act on the petition of **Elwood E. & Elaine S. Hutchens Jr.** The petitioner is requesting a **variance** to construct a new accessory structure for storage at **28 Huron Ave., East Freetown, Mass.** (Assessors' Map 105, Lot 18). The proposed accessory storage structure would have the front and side setback on the property line. The Building Inspector has determined that the Town of Freetown Protective By-Laws (Article 11, Section 11.3) require a 30-foot front yard setback and a 20- foot side and rear setbacks for this property.
